Sale Notice is hereby given to the public in general and in particular to the Borrower (s) and Guarantor (s), that M/S Suneet Traders and Guarantors availed home loan facility from Indian Bank, Barabanki. Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties M/S Suneet Traders (Prop Ram Manoj) failed to pay the outstanding dues to the Bank. As **M/s Suneet Traders** failed to make payment despite Demand Notice, the Authorized Officer took physical /constructive / Symbolic (whichever is applicable) possession of the schedule mentioned properties under the Act on 24.04.2024 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

As per Rule 6 (2) and 8(6) of The Security Interest (Enforcement) Rules 2002 framed under the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002, 30 days notice of intended sale is required to be given and hence we are issuing this notice.
