## **NOTICE OF SALE**

M/s. Mahabir Trading Company, Represented by its Proprietor: Mr. Srikanta Saha had availed loan facilities from Indian Bank, Port Blair Branch, the repayment of which are secured by mortgage of schedule mentioned properties hereinafter referred to as "the Properties". M/s. Mahabir Trading Company, Represented by its Proprietor: Mr. Srikanta Saha had failed to pay the outstanding, therefore a Demand Notice dated 04.01.2024 under Sec 13(2) of Securitisation and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorised Officer calling upon M/s. Mahabir Trading Company, Represented by its Proprietor: Mr. Srikanta Saha and another liable to the Bank to pay the total amount due to the tune of Rs.1,01,39,544/- (Rupees One crore one lakh thirty nine thousand five hundred and forty four only) with further interest, cost and other charges and expenses thereon. Both failed to make payment despite Notice dated 04.01.2024.

As M/s. Mahabir Trading Company, Represented by its Proprietor: Mr. Srikanta Saha failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 14.03.2024 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

THE SALE PROPOSED TO BE HELD IS BY WAY OF PUBLIC TENDER /AUCTION ADOPTING THE e-AUCTION MODE.

As per Rule 6(2) and 8(6) of The Security Interest (Enforcement) Rules 2002 framed under the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002, 30 days notice of intended sale is required to be given and hence we are issuing this notice.

The total amount due as on 30.04.2024 is Rs.1,03,31,000/- (Rupees One crore three lakhs and thirty one thousand only) with further interest, costs, other charges and expenses thereon from 01.05.2024.

Please take note that this is notice of 30 days and the schedule mentioned properties shall be sold under the Act by the undersigned/Authorized Officer any time after 30 days.

The date of sale is fixed as 20.06.2024 from 11.00 a.m. to 4.00 p.m. which would be by e-auction mode.

Inspection of the scheduled properties and related documents/up to date EC etc by the intending purchasers/bidders may be done at their expense from 06.06.2024 to 07.06.2024 between 10.00 am and 4.00 pm.

The Reserve price and Earnest Money Deposit (EMD) for the sale of the secured assets is fixed as mentioned in the schedule.

Further, they are requested to upload requisite KYC documents. Once the KYC documents are verified by e-auction service provider (may take 2 working days), the intending Bidders/ Purchasers have to transfer the EMD amount in his Global EMD Wallet before the e-Auction Date and time in the portal.
