THE TERMS AND CONDITIONS FOR SALE

Sale Notice is hereby given to the public in general and in particular to the Borrower (s) and Guarantor (s), that **Smt Rekha Trivedi D/o Mr Ganesh Shankar Trivedi w/o Mr Vijay Dixit and Mrs Deo Kali Trivedi W/o Mr Ganesh Shankar Trivedi** availed Housing loan facility from Indian Bank, Ahmamau Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as “the Properties”. **Smt Rekha Trivedi D/o Mr Ganesh Shankar Trivedi w/o Mr Vijay Dixit and Mrs Deo Kali Trivedi W/o Mr Ganesh Shankar Trivedi** failed to pay the outstanding dues to the Bank. Both failed to make payment despite **Demand Notice dated 20.12.2023**.

As **Smt Rekha Trivedi D/o Mr Ganesh Shankar Trivedi w/o Mr Vijay Dixit and Mrs Deo Kali Trivedi W/o Mr Ganesh Shankar Trivedi** failed to make payment despite Demand Notice, the Authorized Officer took physical /constructive / Symbolic (whichever is applicable) possession of the schedule mentioned properties under the Securitisation and Reconstruction of Financial Assets and Enforcement of Security Interest Act on **16.04.2024** after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance.
