## **NOTICE OF SALE**

Notice of sale under Rule 6(2) & 8(6) of The Security Interest (Enforcement) Rules 2002 under The Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002

Mr.R. Ashok Kumar and Mrs.A. Nagalakshmi avalled loan facility from Indian Bank, Tirumullalvoyal Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". Mr.R. Ashok Kumar and Mrs.A. Nagalakshmi failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated 05.11.2018 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling Mr.R. Ashok Kumar and Mrs.A. Nagalakshmi liable to the Bank to pay the total amount due to the tune of Rs.28,45,509/- (Rupees Twenty eight lakhs forty five thousand five hundred and nine only) with further interest, costs, other charges and expenses thereon. Both falled to make payment despite Demand Notice dated 05.11.2018.

As Mr.R. Ashok Kumar and Mrs.A. Nagalakshmi failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 19.01.2019 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer Intends selling the schedule mentioned securities in the following mode:

THE SALE PROPOSED TO BE HELD IS BY WAY OF PUBLIC TENDER /AUCTION ADOPTING THE e-AUCTION MODE.

As per Rule 6 (2) and 8(6) of The Security Interest (Enforcement) Rules 2002 framed under the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002, 15 days notice of intended sale is required to be given and hence we are issuing this notice.

The total amount due as on 18.06.2024 is Rs.47,25,280/- (Rupees Forty seven lakes twenty five thousand two hundred and eighty only) with further interest, costs, other charges and expenses thereon from 19.06.2024.

Please take note that this is notice of 15 days and the schedule mentioned properties shall be sold under the Act by the undersigned/Authorized Officer any time after 15 days.

The date of sale is fixed as 09.07.2024 from 11.00 a.m. to 4.00 p.m. which would be by e-auction mode.
