Sub: Your LC facility M/s. Omicron Steel Trades Private Limited bearing account no. 50045943622 with INDIAN BANK SAM BRANCH MUMBAI Reg.

M/s. Omicron Steel Trades Private Limited availed Cash Credit facility from Indian Bank, IF Branch, Mumbai the repayment of which is secured by mortgage/hypothecation of the schedule mentioned properties hereinafter referred to as "the Properties". M/s. Omicron Steel Trades Private Limited failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated 15.09.2021 under Sec.13 [2] of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 [for short called as "The Act"], was issued by the Authorized Officer calling upon M/s. Omicron Steel Trades Private Limited and others liable to the Bank to pay the amount due to the tune of Rs. 28.02 Crore [Rupees Twenty Eight Crore Two Lakhs only] as on 13/09/2021 with further interest, costs, other charges and expenses thereon from 14/09/2021 but M/s. Omicron Steel Trades Private Limited failed to make payment despite Demand Notice dated 15.09.2021.

As **M/s.** Omicron Steel Trades Private Limited failed to make payment despite Demand Notices, the Authorized Officer took symbolic Possession of property under the Act on 21.12.2021 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned/Authorized Officer intends selling the schedule mentioned securities in the following mode:

The sale proposed to be held is by way of public tender/auction adopting the e-auction mode.

As per Rule 6 (2) and 8 (6) of the Security Interest [Enforcement] Rules 2002 framed under the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002, 30 days notice of intended sale as required has been issued, which failed for want of bidders. As sale is being conducted again as per rule 9 (1) of the SARFAESI Act, hence we are issuing this notice.

The amounts due as on 16.11.2022 is Rs. 293228975.87 (Rupees Twenty Nine Crore Thirty Two Lakhs Twenty Eight Thousand Nine Hundred Seventy Five and paise Eighty seven only) with further interest, costs, other charges and expenses thereon from 17.11.2022.

Please take note that this notice of 15 days and the schedule mentioned properties shall be sold under the Act by the undersigned / Authorized officer any time after 15 days.

**The date of sale is fixed on 12.06.2024 which would be by e-auction mode.



The Inspection of the Schedule mentioned property and related documents and up to date EC etc by the intending purchasers/bidders may be done at their expense on 07.06.2024 between 2.00 pm to 4.00 pm.

The Reserve price and Earnest Money Deposit [EMD] for the sale of the secured assets is fixed as mentioned in the schedule.

The Tender / bid Form with the terms and conditions can be had on-line from the website (https://ibapi.in and www.mstcecommerce.com) and using the provision in the system / software. The tender form and the terms and conditions would be available in the website from 24.05.2024 to 11.06.2024 from 11.00 am to 4.00 pm.

The intending Bidders/Purchasers are requested to register with online portal (https://www.mstcecommerce.com/auctionhome/ibapi) using their mobile number and email id. Further, they are requested to upload requisite KYC documents. Once the KYC documents are verified by e-auction service provider (may take 2 working days), The intending Bidders/Purchasers have to transfer the EMD amount in his Global EMD Wallet by NEFT i.e before the e-Auction Date and time in the portal. The registration, verification of KYC documents and transfer of EMD in wallet must be completed well in advance, before auction.

Earnest Money Deposit (EMD) amount as mentioned above shall be paid online or after generation of Challan from the website (https://www.mstcecommerce.com/auctionhome/ibapi) for depositing in bidders Global EMD Wallet. NEFT transfer can be done from any Scheduled Commercial Bank. Payment of EMD by any other mode such as Cheques will not be accepted. Bidders, not depositing the required EMD online, will not be allowed to participate in the e-auction. The Earnest Money Deposit shall not bear any interest.

The Authorized Officer/Bank has the absolute right to accept or reject any bid or adjourn/postpone/cancel the sale without assigning any reason therefore.

The successful bidder shall have to deposit 25% (twenty five percent) of the bid amount, including EMD amount (10%) deposited, latest by the next working day and the remaining amount shall be paid within 15 days from the date of auction in the form of Banker's Cheque/Demand Draft/Account Transfer and/or any other acceptable mode of money transfer.
