TERMS AND CONDITIONS IN RESPECT OF E-AUCTION/ SALE NOTICE DATED 27.05.2024 FOR SALE OF PROPERTY MORTGAGED TO THE JAMMU & KASHMIR BANK LTD BRANCH KADDER, IN CREDIT FACILITY/IES OF FAYAZ AHMAD RATHER

To the best of knowledge and information of the Authorized officer, there are no encumbrances on the properties, except specifically disclosed herein.
