1. Earnest Money Deposit (EMD) amount as mentioned above shall be paid online or after generation of Chalan from the website (<https://www.msfccommerce.com/auctionhome/ibapi>) for depositing in bidder's Global EMD Wallet. NEFT transfer can be done from any Scheduled Commercial Bank. Payment of EMD by any other mode such as Cheques will not be accepted. Bidders not depositing the required EMD online, will not be allowed to participate in the auction. The Earnest Money Deposit shall not bear any interest.

2.
