TERMS AND CONDITIONS

- All conditions of sale shall be governed by the provisions of the Recovery of Debts Due to Banks and Financial Institutions Act, 1993 read with the Second & the Third Schedules to the Income Tax Act, 1961 and the Income Tax (Certificate Proceedings) Rules 1962 and also guided by the Information Technology Act 2000 as amended from time to time.
- Property is sold on "as is and where is /on what it is/ no compliant basis".
- 3. Property can be inspected in consultation with the Authorized Officer of the CH bank.
- 4. Bids shall be submitted online before the last date and time given in the sale notice/tender document.
- 5. The bid shall be accompanied by the EMD as specified in the public sale notice/tender document.
- 6. The e-Auction shall commence strictly at the scheduled time and above the highest quotation received. Auction/Bidding time will initially be for a period of one hour and the closing time of the

- auction is system controlled; the time will get automatically extended by five minutes if any bid is received during the last five minutes, i.e. while active bid is in process and kept open till the auction-sale concludes.
- 7. Highest bid will be provisionally accepted on "subject-to-approval" basis and the highest bidder shall not have any right/title over the property until the sale is confirmed in his/her favour.
- 8. Intimation will be sent to the highest bidder through e-mail. Date of sending e-mail will be considered as date of intimation.
