Sehore: The 70-year-old wife of a former legislator of the BJP Madan Lal Tyagi, Vidy Devi, was run over by a train on Monday morning, the police said. On getting information, the police rushed to the spot and began an inquiry after the post mortem. According to reports, she went out of her residence for a morning walk at 5:30am. When she was crossing the railway track of the Housing Board, a train ran over her. She had some stomach-related problems, so she used to go for morning walk daily.

Man arrested for murdering wife

He suspected that his wife had relation with another man. Took kin's help to execute murder

The police have arrested a man and his relative for murdering his wife, official sources said. The brother-in-law of the man (sister's husband) was also arrested for helping the man to execute the crime.

A towel used to commit the murder was also recovered from their possession.

The criminals identified themselves as 40-year-old Pushpendra Raja, resident of Bhairu village under Maharauni police station and 25-year-old Tinku Raja aka Amrendra Singh, resident of Khokhra.

According to reports, the father of the woman complained that Pushpendra and Amrendra had murdered his daughter for getting possession of land.

The police began to probe the case on the basis of the post mortem report and the complaint.

To arrest the culprits, a team consisting of SGO officials, surveillance offi-

cial and cops of the police station was set up.

The team examined the CCTV cameras, CDR and other documents and arrested the criminals.

When Pushpendra Raja was questioned, he said he had been married 14 years ago, and had three children from the wedlock. Pushpendra said that his wife used to talk to some other person by changing her mobile number.

As he used to fight with his wife over the issue, she went to her parents' house, Pushpendra said, adding that he bought a piece of land and got it registered in the name of both of them.

Pushpendra further said when his wife had not stopped talking to the person, he mounted pressure on her to give up the land, but she was not ready.

He further said that he had contacted Amrendra and made him part of the conspiracy to murder his wife. Pushpendra said his brother-in-law Amrendra had come to his house in Talabpura.

According to Pushpendra, he just pinned her down to the ground and used an old towel to choke her to death with the help of amrendra.

The heatwave sweeping across the state wreaked havoc in Chhatarpur on the third day of the Nautapa (hottest nine days during summers), as the mercury shot up to the 46 degrees Celsius mark on Monday. With this, Monday was recorded as the hottest day in Chhatarpur this summer. The situation had come to such a pass that the people were leaving their homes even at 8 in the morning



with their faces covered. Meanwhile, in the noon, the roads went deserted amid the scorching temperatures. Owing to the unmatched heat levels, the tourism in Khajuraho has also suffered a significant blow, and the businessmen

have landed in troubled waters, as their businesses are seeing a low. The weather office in Khajuraho has issued a heatwave alert for the entire district, and has announced that the temperature is expected to soar in the upcoming days.

30-yr-old man kills self inside forest

Bhopal: A man said to be in his 30s allegedly died by suicide inside a forest close to Khajuri Sadak on Monday morning, the police said. The deceased was identified as Mukesh Malviya, a private company employee.

According to Khajuri Sadak police, the incident came to light when the residents of a village linked to Khajuri went to the forest and found Malviya hanging from a tree. They immediately informed the police, who rushed to the spot, and ascertained his identity.

The police informed his kin about the incident and it was learnt that Malviya was married and had three kids. He was an alcohol addict and often used to quarrel with his wife in an inebriated state. On Sunday night too, he had argued with his wife and then left home in a fit of rage. He went to the forest and hanged himself to a tree. The police sent his body for post-mortem. No suicide note was recovered from the spot and efforts were on to ascertain the reason behind his extreme step.

Patwari commits suicide week before wedding

A 26-year-old youth who was selected for the post of Patwari committed suicide by hanging himself from a branch of a tree behind Rani Durgawati College in Linga village under Paraswada police station. He was to get married on June 3.



The youth was identified as Atul Chichkhede, son of Narayan Chichkhede, a resident of Linga village under Paraswada police station.

The police found a suicide note in which Atul wrote that he had taken the extreme step for not being happy about the wedding. The police took the body into their custody and began to probe the case.

After being selected for the post of Patwari, he was undergoing training at the Balaghat Patwari Training

Centre. He was going to get married on June 3. Atul used to return home daily after completion of his training, but when he did not return home on Saturday, his family members called him up on his mobile phone which was switched off.

When the family members did not find him anywhere, they found him hanging from the branch of a tree behind Rani Durgawati College.

His family members said Atul may have committed suicide because he was not ready to get married.

In the suicide note, he wrote that as he had been in deep depression, he took the extreme step on his own, but he did not want to get married.

He further wrote that he had tried to break the marriage, but neither his family members nor his friends should be harassed for it.

Woman, son, daughter beat up each other at district hospital

Unchehara (Satna): There was a drama of sorts on the premises of the Satna district hospital on Monday when a woman, her son and daughter fiercely fought with each other.

The fight continued for a long time and a large number of onlookers. The hospital staff and policemen brought the situation under control. According to reports, a resident of Majgawan Rani Pandey came to the hospital along with son

for the treatment of her husband. Meanwhile, her daughter Anju, together with a friend also reached the hospital and began to beat up her mother and brother at the hospital gate. Some people tried to stop the fight, but they could not. The family members did not say anything about the reason for the brawl. Some policemen and the hospital rushed to the spot and brought the situation under control.

President of the group Rajesh Bhat said organisation had invited artistes from Mumbai, Delhi and Kolkata in Lineage-1. The specialty of this group is that all the singers in it are seven brothers from the same family and their three generations. Music lovers of Bhopal will get to hear songs with variety in this programme.

Two members of Irani gang held

Indore: Two members of an Irani gang were arrested by Banganga police for stealing gold rings from a jewellery shop and recovered 19 stolen rings, police said on Monday. On May 10, two unidentified individuals decamped with 25 gold rings from a jewellery shop and the entire incident was captured on CCTVs installed at the shop. Later, a case was registered against the accused on May 16. The accused engaged the shopkeeper in their conversation and asked him to show gold rings and managed to steal 25 gold rings kept in a box. According to the police, the accused has been identified as Zakir Hussain of Bhopal district and Amjad Ali of Ratlam district. During interrogation, they allegedly confessed to their crime and are being further interrogated for any previous criminal records.

UNCHEHARA CHC LACKS FACILITIES

The community health centre at Unchehara, where over a dozen doctors have been posted, lacks facilities. But the doctors at the OPD are not found, and the patients are facing problems daily. According to sources in the hospital, the clerks handling the patients often deny them any facility. They sometimes also misbehave with the patients. Nevertheless, those who are responsible for managing the hospital have turned a blind to the problems the patients are facing. Although a generator has been installed at the hospital to supply power if electricity goes off, but the generator is never used, sources further said. As a result, the patients and their attendants face many problems. According to patients, although there are many doctors at the hospital, none of them is found in OPD.
