M/s Mansi Manufacturing Company availed cash credit facility from Indian Bank, Jasola Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". M/s Mansi Manufacturing Company failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated 10.01.2023 Under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized officer for Rs18,35,097 (Eighteen Lakhs Thirty Five Thousand and Ninety seven Only) as on 28.09.2020 with further interest, costs, other charges and expenses thereon. All failed to make payment despite Demand Notice dated 10.01.2023

As M/s Mansi Manufacturing Company failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 24.05.2023 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to affect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:
