## **E-Auction Sale Notice**

## SALE OF IMMOVABLE PROPERTY MORTGAGED TO THE BANK UNDER THE SECURITISATION AND RECONSTRUCTION OF FINANCIAL ASSETS AND ENFORCEMENT OF SECURITY INTEREST ACT, 2002

Whereas i)**Mr. Vurimi Venkateswara Rao**, S/o. Venkaiah ii) **Mrs. Vurimi Rama Devi** W/o. Vurimi Venkateswara Rao have borrowed monies from Indian Overseas Bank against the mortgage of the immovable property more fully described in the schedule hereunder and on upon classification of the account as NPA, the Bank has issued a **Demand Notice** to the Borrowers under Section 13(2) of the SARFAESI Act, 2002 (Act) on **27/09/2023** calling upon the borrowers **Mr. Vurimi Venkateswara Rao** S/o. Whereas the borrower having failed to pay the amount dues in full to the bank as called for in the said demand notice, the bank has taken possession of the secured assets more fully described in the schedule hereunder on 05.01.2024 under Section 13(4) of the Act with the right to sell the same in "As is where is" and "As is what is" basis under section 13(4) of the Act read with the rules 8&9 of the Security Interest (Enforcement) rules, 2002 for realization of Bank's dues. The dues to the bank as on the date of taking possession was intimated as **Rs.18,20,573.00 (Rupees Eighteen Lakhs Twenty Thousand Five Hundred Seventy Three only) (i.e Housing loan outstanding Rs.7,23,825.45 + Loan against Property outstanding of Rs.10,96,747.55) as on 04.01.2024 payable together with further interest at contractual rates and rests along with costs, charges etc till date of repayment, after reckoning repayments, if any, since the date mentioned in the demand notice.** 

The dues of the borrower **as on 13/06/2024 is Rs.15,26,295.95 (Rupees Fifteen Lakhs Twenty Six thousand Two Hundred Ninety Five and paise Ninety Five Only)** along with further interest\_after reckoning repayments if any subsequent to the bank issuing the demand notice.
