
nearly six years, returned home three years ago. The rescued woman is

SIT moves CBI over Blue Corner notice against Prajwal

Bengaluru: THE Special Investigation Team (SIT), which is probing the alleged rape and sexual harassment cases against Hassan MP Prajwal Revanna, has approached the CBI to issue a Blue Corner notice against him. The Blue Corner notice is issued to collect information about the accused's movement, location or activities. Since Prajwal has gone abroad using his diplomatic passport, the central agencies will have his travel details. Without SIT approaching them, the CBI cannot directly issue the Blue Corner notice against Prajwal. The chief minister held a meeting with SIT officials and instructed the officials to take immediate action to arrest him. Prajwal did not appear before the SIT although it issued a notice to him. He is said to have gone to Germany on April 27. The MP through his advocate, had sought a week's time to appear before the SIT which was turned down. It is said that Praiwal has booked a return ticket to Bengaluru from Munich and will land in Bengaluru in the wee hours of May 16.

THE FRS software was developed by CDAC (Centre for Development of Advanced Computing) Kolkata and the application is hosted on the server at TNSDC (ELCOT). The compromised FIR details includes FIR ID, number, police station, investigating officer, date of registration, status of case, names in the FIRs, age, gender, parentage and address. The data is available for sale in a hackers' forum for 2\$ to 3\$.

FalconFeeds.io stated that it is unclear whether the samples are part of a larger database or if the hacker has only accessed this specific set of information. "We are analysing the full data set and will provide information soon," Falcon-Feeds said.

Director General of Police said, "On preliminary enquiry, it is learnt that the password has been compromised in admin account. The admin account has limited rights like creation of id for users and details of front end can only be viewed." The last security audit was carried out on March 13. As a preventive measure, the admin account has been deactivated. The unauthorised user can view only the front end data (creation of id for users, queries search) and hence could access the backend data & main server data. A complaint was lodged at Cyber Crime Police Station, Chennai, and information was communicated to ELCOT, TNeGA, CDAC-Kolkata.
