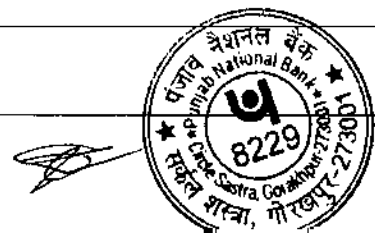

Further, they will upload the requisite KYC documents. 
