Description of property

All that piece and parcel of the property situated in Kancheepuram District, Kancheepuram Taluk and Town, in 4th Division, in Senkazhu Nerrodai Street, at the northern row, in Town S.No. 1534, the property measuring East to West on the Southern side 17 feet, on the Northern side 16 feet, North to South 69 feet, (As per Municipal Survey Sketch 17-16 X 82), in this the front southern portion adjacent to Sengaluneerodai Street, measuring East to West 17 feet including 3 feet western side Narasam and North to South 50 feet, total sq.ft., 850, with proposed construction of RCC roofed residential 1st floor, 2nd floor and 3rd floor buildings each measuring 503 Sq.ft, as detailed in the unapproved building plan mentioned as document No. 19, in Sub division New S.No. 1534/2C and Narasam 1534/3, in Door No. 36, Tap Connection, Drainage connection and EB Service connection No. 301-034-629 bounded by:

Terms and Conditions of E - Auction

2. The intending bidders of the property should send their bids in the prescribed tender form in a closed cover along with EMD of 10% of the reserve price by means of RTGS / NEFT / DD / Banker's Cheque drawn in favour of "**Repco Home Finance Limited**" payable at **Kanchipuram** or on the website **www.bankeauctions.com** Tender form not in the prescribed format will not be accepted.
3. The EMD amount is refundable **without interest** to the bidder if the bid is not successful.
4. Offer without EMD and below the reserve price will be rejected.
5. The EMD amount shall be liable for forfeiture without any prior notice, if the successful/ bidder fails to adhere to the terms of sale.
6. After opening the tenders, the intending bidders may be given an opportunity at the discretion of the authorized officer to have, interse bidding amongst themselves to enhance the offer price.
